#### II. Reports

# A. President's Report

The President thanked everyone for all of their help, collaboration, participation and enthusiasm in working with the Aspen team from their 8 AM arrival until they departed the campus at 4:30 PM. They met with every group at our very large and complex campus. They came back impressed from every meeting with administrators, faculty, staff and students. They really believed that people here at KCC really care about our students, collaborating to help student success. We did as well as we could, which is all anyone could ask.

We did receive two Aspen requests, one for a release to track data on how many of our students eventually graduate from 4-year colleges, and another to sign a release to get data on our former students in the labor force. Unfortunately it is illegal to release that information in New York state, so we were unable to comply.

The President expressed her pleasure at meeting with faculty in their departmental meetings and hearing their responses to college charts and data, as well as their suggestions for improvement.

She congratulated the Office of College Advancement on a wonderful and successful Homecoming Day. On a related note, she urged anyone who has not yet seen the new campus broadcasting studio to stop by and see how professionally it was put together.

The College Food bank has been depleted and many of our students need food, canned goods to support a meal, or donations to help provide meals, particularly during Thanksgiving season. Many campuses do not address this very real problem, but we are making a strong effort to help students address their needs.

Finally, the Child Development Center at KCC is celbrating its 40<sup>th</sup> anniversary at a dinner scheduled for November 1. Seats are still available, so interested parties should see Dean Basile about getting tickets.
