#### A. World Cultures and Global Issues

A Flexible Core course must meet the three learning outcomes in the right column.

Different modes of historical, sociological, and anthropolgical methodology come into play. Special attention is given to archeology and its unique methodology, especially early in the course. The development of the People of Israel from a tribe to a world nation and global religio-ethnic community is the crux of the course. • Analyze and discuss common institutions or patterns of life in contemporary U.S. society and how they influence, or are influenced by, race, ethnicity, class, gender, sexual orientation, belief, or other forms of social differentiation.

#### C. Creative Expression

A Flexible Core course must meet the three learning outcomes in the right column.

## E. Scientific World
