PSY 2400 - PSYCHOLOGICAL DISORDERS IN YOUNG CHILDREN (3 crs. 3 hrs.)

Psychological disorders in young children and the practices required to deal with them in early childhood settings. The problems and needs of gifted children, children who are mentally retarded or minimally brain-damaged, deaf, blind, orthopedic or speech handicapped. Causes, diagnostic, therapeutic and educational procedures and teaching methods are reviewed for each category based upon principles learned in introductory psychology courses.

New York State mandated two-hour session on recognizing and reporting child abuse is included.

Prerequisite: PSY 3000 or PSY 3200

PSY 2400 – PSYCHOLOGICAL DISORDERS IN YOUNG CHILDREN (3 crs. 3 hrs.)

Psychological disorders in young children and the practices required to deal with them in educational settings. The problems and needs of children with behavioral, emotional, intellectual, developmental and sensory disabilities are studied. The causes, diagnostics, therapeutic and educational interventions with teaching methods are reviewed for each category based upon principles learned in introductory and developmental psychology courses.

New York State mandated two-hour session on recognizing and reporting child abuse is included.

Prerequisite: PSY 3000 or PSY 3200

## Rationale:

The terminology in the previous description is not compliant with the Individuals with Disabilities Education Act. The new description more accurately reflects the current course.
