RATIFICATION OF THE CONSTITUTION

The last time the Board of Trustees approved the KCC Constitution was many years ago. Since then, the KCC Constitution has undergone multiple revisions but has not been ratified. In the past couple of months, the Legislative Committee, chaired by Shoshana Freidman, has been working hard analyzing previous drafts of the

Constitution and College Council Meeting Minutes. The Legislative team has complied an updated Constitution based on items that the College Council has already approved, making the document more readable.

The ratification process is important because it shows that the college community approves all the changes made at the College Council since the last ratification. Additionally, when the Middle States team arrives in late March, we can inform the Middle States team that we believe in our shared governance and are awaiting CUNY's Board of Trustees approval. The updated ratified Constitution is not set in stone. Below is the

Special Rules of order for the March 18, 2025 College Council meeting on amending the Constitution. After the Constitution is ratified, it can be changed based on the proper Two-Meeting Rule procedures. An approved vote allows our Constitution to go to the Board of Trustees for approval.

Special Rules of Order for Ratification of Constitution March 2025

STEP	ACTION
Notification	Proposed Constitution must be posted/announced (a reasonable time) prior to the Meeting
	at which the Ratification Vote will occur.
Amend	A member may move to Amend the Proposed Constitution by saying "I move to amend the
	proposed constitution as submitted to the Secretary."
	Motion to Amend must be given to the Secretary in writing prior to the start of the
	Meeting.
• States	The Chair states the motion. (Places it on the view screen for all to read.)
Second	Another member must second the motion by saying "I second it."
Poll to Discuss	The Chair polls the members.
	Majority (show of hands) required to Discuss, else motion is tabled.
Discuss	The maker of the motion starts the discussion.
End of Discussion	The chair closes discussion at the chair's discretion.
	(Can be overruled by a majority of members.)
• Vote	Motion to Amend the Proposed Constitution requires two-thirds vote of Quorum.
Voting	Ratification of Proposed Constitution requires two-thirds vote of Quorum.

Information about the Special Rules of Order was presented at the February 11, 2025 College Council by the Parliamentarian John Mikalopas. The Parliamentarian would like to emphasize that we must have a Constitution approved by the CUNY's Board of Trustees and the Constitution can continue to be altered under Regular Order.
